Subject: Eido T. Shimano and the Zen Studies Society, Inc.

Dear Sir/Madam,

I am writing to inform you of a situation of longstanding abuse and manipulation of students at the above-mentioned religious organisation, the Zen Studies Society, Inc. (ZSS). Briefly stated, Mr. Eido T. Shimano, the abbott of the ZSS's monastery in upstate New York, has been accused of (among other things) sexually predating on dozens of female students over a period spanning almost fifty years. The situation is not completely unknown to the public, as both the New York Times¹ and the Survivors' Network of those Abused by Priests (SNAP)² have covered the story. However, as of today, not only does Mr. Shimano continue to remorselessly deny any wrongdoing, but the ZSS still refuses to openly engage with his victims and instead stands steadfastly behind their beloved teacher.

A unique aspect of this case is that said abuse by Shimano, and the accompanying collaboration by successive ZSS boards of directors, has already been painstakingly documented and made publicly available. The website www.shimanoarchive.com provides a fascinating glimpse into the workings of a clearly cultish group and their charismatic leader. Although I of course invite you to examine the entirety of this evidence yourselves, allow me in the present letter to at least direct you to certain sample documents which I believe make a good prima facie case.

To begin, the most damning documents are of course those that provide first-person accounts of Mr. Shimano's numerous sexual aggressions against his students. Indeed, the evidence thereof has since become so mountainous that even his most devoted followers are slowly mitigating their expressions of adoration. Both the aforementioned New York Times article and the 1982 report Zen and the Art of Seduction³ provide good, objective summaries in this regard.

Next, please examine some examples of the cult-like denial and intimidation demonstrated by Shimano's followers, which have enabled him to unabashedly continue said abuse for decades. Although I am aware that a 'cult' can be defined in many different ways, for the present purposes I have taken some key signs enumerated in the article *How to spot a Buddhist* cult* by Upasaka HL Wai and referenced to evidence thereof in specific Shimano Archive documents. For ease of understanding I have also added some short explanations of unfamiliar terms in square brackets.

By the way, none of the four men I am referring to are members of AZTA, but please be aware that a man who was declined membership in AZTA, in part because Eido Roshi would not acknowledged [sic!] him as a Dharma Teacher, started the current wave of vilification."

Indeed, I do not share that same confidence that I once did and this is so because many reliable sources have reported to me that the spiritual stature of the Zen Studies Society has been compromised over the years because of Eido Roshi's behaviour."
	An appeal by ZSS to build a \$100,000 entry gate dated 06/10/10	"To commemorate Eido Roshi's 50th Anniversary in the United States, and to express his gratitude to the Three Treasures, a Sanmon (gate complex) will be built at the entrance of Dai Bosatsu Zendo [ZSS monastery]. The total cost will be approximately \$100,000. Please join Eido Roshi in making this historical project a reality."

If Zen practice has not helped the person move on, seeing a counselor or therapist is in order. Some psychological issues need the kind of help provided by a professional."

A young military vet who 'lost it' in the Zendo [meditation hall], 'went off the deep end psychologically' and had to be picked up by parents. Another student, myself, who temporarily 'went off the deep end' into what psychiatrists might call paranoid schizophrenia. Meanwhile Eido Roshi was still having or attempting to have sexual relationships with students [] Is there a connection between the 'crazy' behavior of a few students and Eido Roshi's 'lack of morality' (as he once put it)?"

	A letter from Christopher Hamacher to the ZSS board of directors dated 09/04/10	"However, when I got back up afterwards and glanced at him [Shimano], I was taken aback by the expression on his face. He was practically glowing, with great, round eyes and an enigmatic smile, as if he had just given me some extraordinary gift, and was waiting for the corresponding acknowledgement. It was just a brief moment, but nevertheless extremely unsettling. Not only had he misunderstood what had just (not) happened, but he was also clearly hoping for a definite emotional response from me."

Allow me just to add that several of the more disconcertingly pro-Shimano comments above were made by people who currently sit on the ZSS board of directors. They thus are currently in a position of power to oppose any internal action initiated against him. Indeed, as a detailed examination of the Archives shows, not only was Shimano himself a member of the board for decades, but he was also apparently allowed to hand-pick <u>all</u> of his fellow board

members - including his own wife as treasurer and director of a ZSS temple - during that time. The ensuing grievous, systemic conflict of interest was clearly a major factor in the numerous cover-ups of his abuse over the years, and continues to thwart any kind of remediation today.

In conclusion, I repeat that the above selection constitutes merely a small fraction of the hundreds of documents contained in the Shimano Archive. I trust, however, that you now have at least enough evidence to merit your further investigation of this case. I would thus appreciate it if, once you have undertaken a more thorough analysis, you could provide me with some suggestions on how a concerned outside party should proceed in addressing these problems. I also of course hope that you will help publicise the case more widely, via any channels to which you have access. I underline that, as of today, Mr. Shimano currently remains in an official capacity within the ZSS, perhaps even under salary, and no effective action to address any of the harm caused has been undertaken. There is therefore a very real danger that the cycle of abuse will continue.

Finally, please note that at least two lawsuits against Shimano and the ZSS are apparently being prepared. Several former ZSS residents/Shimano victims have also indicated a willingness to share their experiences with you directly. I will gladly provide you with appropriate contact information or any other details, should you so require.
